The Reorganization Meeting of Sellersville Borough Council was called to order on January 5, 2026, at 7:00 p.m. by Mayor Thomas Hufnagle. All present joined in offering our National Pledge of Allegiance.

III. OATH OF OFFICE:

Mayor Thomas C. Hufnagle administered the Oath of Office to the following people:

V. ELECTION OF PRESIDENT:

Mayor Hufnagle called for nominations for the Office of Council President.

Mrs. Howells made a motion to nominate Donald Crouthamel as President of Council, with Ms. Saylor seconding the motion. With no other nominations coming from the floor, all were in favor of Mr. Crouthamel's election as President of Council.

Mayor Hufnagle then turned the meeting over to President Crouthamel.

VI. ELECTION OF OFFICERS OF COUNCIL:

Mr. Crouthamel called for nominations for the Office of Council Vice President.

Ms. Saylor made a motion to nominate James Hull as Vice President of Council, with Mrs. Howells seconding the motion. Mr.

O'Donnell made a motion to nominate Lois Dodson as Vice President of Council; motion failed. With no other nominations coming from the floor, all were in favor of Mr. Hull's election as Vice President.

Mr. Crouthamel then called for nominations for the Office of Council President Pro Tempore.

Mrs. Howells made a motion to nominate Lois Dodson as President Pro Tempore of Council, with Mr. O'Donnell seconding the motion. With no other nominations coming from the floor, all were in favor of Ms. Dodson's election as President Pro Tempore.

VII. APPROVAL OF 2026 APPOINTMENTS AS RESOLUTION #2026-01

Mrs. Detweiler presented a Resolution outlining appointments to Boards, Commissions, and other Borough positions. The Resolution also set down authorized Borough Depositories.

A motion was made by Mrs. Hallman and seconded by Mr. Hull to approve Resolution #2026-01, the Appointments Resolution. The motion carried unanimously.

VIII. SET TREASURER'S BOND:

Mrs. Detweiler recommended setting the Treasurer's Bond at \$150,000.00.

A motion was made by Ms. Saylor, seconded by Mr. O'Donnell, and unanimously carried, to authorize setting the Treasurer's Bond at \$150,000.00.

IX. APPROVAL OF 2026 FEE SCHEDULE AS RESOLUTION #2026-02:

Mrs. Detweiler presented proposed Resolution #2026-02, a restatement of all fees and charges that the Borough levies for goods and services.

A motion was made by Mr. O'Donnell, seconded by Mr. Hull, and unanimously approved, to adopt Resolution #2026-02, the 2026 Borough Fee Schedule, with the amendment of the trash rate description from twice-a-week pickup to once-a-week pickup.

X. ACCEPTANCE OF PERKASIE POLICE PERSONNEL AS RESOLUTION #2026-03:

Mrs. Detweiler presented a Roster of Perkasio Police Department sworn officers who serve Sellersville Borough, and asked that Council adopt Resolution #2026-03, appointing each individually to serve Sellersville Borough under the terms of the Joint Municipal Agreement for Law Enforcement Services between Sellersville and Perkasio Boroughs.

A motion was made by Mrs. Howells, seconded by Mr. Hull, and unanimously approved, to adopt Resolution #2026-03, appointing, accepting, and approving the Roster of Perkasio Police Department sworn officers.

XI. OTHER:

No other business was discussed.

XII. ADJOURNMENT:

There being no additional matters to come before this meeting of Borough Council, President Donald Crouthamel declared the meeting duly adjourned at 7:26 p.m. The next Regular Council meeting was scheduled for Monday, January 12, 2026, at 7:00 p.m.
