# **NUISANCE HEARING - 216 WASHINGTON AVENUE**

President Dodson opened the Nuisance Hearing regarding, the property at 216 Washington Avenue, Sellersville, PA 18960 owned by Robert Van Demark. She turned the proceedings over to Solicitor Randal White. Mr. White began the hearing by explaining the procedure that would be followed which is to call Manager Rivet and Mayor Hufnagle as witnesses, have them individually sworn in by the court stenographer and then questioned on their findings of a nuisance situation at the subject property. The witnesses could also be asked questions by Council. Sworn testimony from others in the audience who wished to speak would then be allowed.

Manager Rivet was asked if he would recognize Mr. Robert Van Demark and if so, if the subject was present. Mr. Rivet stated he would recognize him and that Van Demark was not present. He was then questioned on his Nuisance Investigation report of November 9, 2018 and accompanying photographs; his November 12, 2018 Notice of Violation letter; December 20, 2018 Notice to Van Demark regarding the Nuisance hearing; photographs taken January 4, 2019 and to discuss previous notices Van Demark had been given since 2013 regarding high grass, his dogs defecating and urinating on neighboring properties as well as his failure to clear snow from the sidewalk.

Mayor Hufnagle was then disposed and questioned on his November 12, 2018 Investigation and Report of Nuisance Violation and the follow-up report to Council dated December 10, 2018.

Neighbor Lauren Gorr, 224 Washington Avenue was sworn in and stated that she has lived at her residence since 1989 and that the situation living next to Van Demark has been intolerable. The junk, noise, large number of questionable people who have come and gone, his erratic behavior and dog urinating and defecating on her lawn has made her life very difficult.

Barry Kuhn, 121 West Church Street stated that in the winter of 2013-14, Van Demark drove a truck over his property, while driving without a license, and did over \$1,000 in damage. Mr. Kuhn took Van Demark to court and was awarded damages and no contact with him. Van Demark did not pay and the court gave Van Demark 90 days in jail for contempt of court. In

November 2018, Van Demark had debris in his back garage entrance that was extensive enough that it fell into the alley. Mr. Kuhn stated that Van Demark should be thrown into jail, the house sold and restitution given to all owned money by Van Demark.

Kathy Dabanian, 210 Washington Avenue, presented a printout of a series of emails she has sent to Police Chief Hillias over time regarding her problems with Van Demark. She stated that living next to him has been a nightmare. She that the junk, noise, large number of questionable people who have come and gone, erratic behavior and his dog urinating and defecating on her lawn has made her life intolerable and she hates coming home.

Councilman Crouthamel asked Detective Sgt. Closs if there had been any mental health referrals for Van Demark. Sgt. Closs stated none of which he was aware.

Solicitor White informed the Council that he would review the hearing transcripts when complete, draft a conclusion and finding of law and prepare recommendations to Council for action. President Dodson closed the hearing at 8:25 p.m.

Council took a recess and reconvened at 8:35 p.m.
