A motion was made by Mr. Hull that the Consent Calendar, Items (A) through (I), be approved as presented. Mrs. Hallman seconded and the motion carried unanimously.

CITIZEN PARTICIPATION:

Public Hearing on Comprehensive Plan:

President Dodson opened the public hearing for discussion on the updated Sellersville Borough Comprehensive Plan at 7:04 p.m. Manager Rivet briefly reviewed the history of the process of developing the updated plan. No persons present spoke on the plan. President Dodson closed the public hearing at 7:07 p.m. Mr. Crouthamel moved to adopt the updated Comprehensive Plan as presented. Motion was seconded by Mr. Potoczny and passed with all in favor.

Members of the Nase-Kraft American Legion Post addressed Council regarding the recent letter sent to the Legion on the Zoning ordinance violation for having a portable sign in the commercial district. Mr. Craig Wilhelm first thanked the council and mayor for their role in dedicating the recently reconstructed bridge in honor of local veterans. Mr. Wilhelm, Frank Brown, Lloyd Dooley and Paul McCabe requested that the council give reconsideration of the sign ordinance as not being able to use them to advertise hurts business. They stated that the Legion donates as much as \$30-40,000 dollars to the community.

NEW BUSINESS:

A. Ordinances

Ordinance No. 731- an ordinance fixing the real estate tax for the fiscal and calendar year 2020 and continuing in effect a per capita tax, occupation tax, and real estate transfer tax. The general fund real estate tax remained at 24 mills and a new special purpose fire protection real estate tax was established at 3 mills. Ordinance No. 731 was moved for approval by Mr. Crouthamel. Motion was seconded by Mr. Potoczny and passed with all in favor.

B. Resolutions

Resolution #19-13 - establishing a fee schedule for recreation field use and municipal claims was moved for approval by Mr. Hull. Motion was seconded by Mr. Crouthamel and passed with all in favor.

Resolution #19-14 - appropriating specific sums estimated to be required for specific purposes of the borough during fiscal year 2020 was moved for approval by Mr. Hull. Motion was seconded by Mrs. Howells and passed with all in favor.

Resolution#19-15 – appointing Styer and Associates Certified Public Accountants for the purpose of official audit of the accounts and other evidences of the borough for fiscal year 2019 was moved for approval by Mr. Potoczny. Motion was seconded by Mr. Hull and passed with all in favor.

Resolution #19-16 —providing a block grant in the amount of \$7,200 to the Sellersville Fire Department for the year 2019, was moved for approval by Mr. Hull. Motion was seconded by Mrs. Hallman and passed with all in favor.

Manager Rivet informed the Council that the Blighted Properties Review Committee met on December 6, 2019 and passed a resolution finding 216 Washington Avenue meeting at least four of five criteria for being a blighted property. The Sellersville Planning Commission will next review the evidence and if in agreement, will also pass a resolution that will go to the Bucks County Redevelopment Authority who can then begin an eminent domain proceeding against the property.
