UNFINISHED BUSINESS:

Chief Hillias updated Council and Mayor on the new medical marijuana dispensary, TerraVida and so far all is going well. Their head of security is a 30 year police veteran. The head of security and Perkasie Police have met to open lines of communication. The review of the 2017 police budget is almost complete and it appears there may be a refund to Sellersville Borough.

NEW BUSINESS:

Mr. Hull moved to appoint Sue Snyder to the position of Treasurer effective May 1, 2018 at a prorated stipend of \$2,760 annually. Motion was seconded by Mrs. Hallman and passed with all in favor.

Mr. Hull moved to hire Michael Zischang as laborer at a starting wage of \$22.50/hour, to increase to \$23.00/hour upon successfully obtaining a Commercial Driver's License. Motion was seconded by Mr. Crouthamel and passed with all in favor.

Mrs. Howells moved to authorize the sale of up to 25 sewer EDU's to Hilltown Township Water & Sewer Authority at a price of \$3,600 per EDU. Motion was seconded by Mrs. Hallman and passed with all in favor.

E. Agreements

Mr. Hull moved to approve the bids received from Nice Contractors, Inc, for Lawn Maintenance. Motion was seconded by Mr. Potoczny and passed with all in favor.

OTHER BUSINESS

Mrs. Hallman inquired as to who picked up the sticks in the playground. Manager stated that a group of young people did it. She further noted that a number of trees had been uprooted in the park during the March 2nd winter storm. She congratulated the Manager on the Standard & Poors bond ratings upgrade.

Mr. Crouthamel asked Police Chief Hillias what he sees as issues in the community. Chief Hillias stated that both Perkasie and Sellersville are great communities that he enjoys serving. The biggest challenge currently is the opioid crisis and the related crimes that go with it.

Mrs. Howells announced that at the next Bucks County Borough's Association meeting March 27, 2018, the Bucks County District Attorney will be the guest speaker.
