#### RECORDER OF DEEDS BOOK PRESERVATION DONATION

At the April 8<sup>th</sup> Council meeting, Robin Robinson, Bucks County Recorder of Deeds gave a presentation on her efforts to preserve the historic deed and other books under her offices' care. Recorder of Deeds Robinson stated that she was looking for financial assistance in the very expensive preservation process. Mr. Hull moved to donate \$1,000 to the book preservation effort. Motion was seconded by Mr. Crouthamel and passed with all in favor.

#### **EMAIL FROM PENNRIDGE STUDENT-COMMUNITY CENTER**

PMC discussed the email that council members received from Oliva Ferraro requesting that he borough establish a free community center for youths aged 12 -18. After some discussion, it was decided to invite Ms. Ferraro to a PMC meeting to discuss her thoughts and possibly be a Junior Councilperson.

#### OTHER

Chair Dodson read an email from a resident at the Mews whose daughter's car was towed while visiting her parents. The towing was done at the behest of a HOA Board member and is not a borough issue.

Mr. Crouthamel presented a draft resolution to request state and federal lawmakers to pass sensible gun control measures. The resolution was based on one passed by Newtown Borough. The resolution will be on the Council's May agenda.

There was also discussion regarding detour routes for the business district when the Main Street bridge over the SEPTA tracks is closed. Manger stated that Penn DOT will be posting signs outside the borough that state that there is access to downtown businesses. The orange and black detour signs the borough posted the last time it was closed will also be reinstalled.

The Pennridge Waste Water Treatment Authority 2018 financial statements and the borough's taking over ownership of the train station were also briefly discussed.
